HOW TO APPLY

Congratulations on your decision to apply to the Sacred Sounds Yoga Teacher Training program!

To apply for the program, please email the completed application to us at tt@sacredsoundsyoga.com. Upon notification of your acceptance, a non-refundable \$500 deposit will be due to reserve your place in the program. In order to receive the Early Bird rate, your tuition must be paid in full by the Early Bird deadline. Full payment is due no later than the start of the program. Enrollment is limited, and we may accept last minute applications only if there is space in the program. Tuition includes unlimited classes at Sacred Sounds Yoga starting the first training date through the last training date.

PARTICIPATION AGREEMENT

I understand that, if I am paid in full and fulfill all the requirements of the Sacred Sounds Yoga Teacher Training, including but not limited to complying with in-class hours, completing written homework, taking at least three classes per week, at least one of which is with a lead teacher, another of which is with a vinyasa teacher (either lead or non-lead), and the third of which is with any teacher, submitting my Class Log, Program Log and Class Observation Notes, and passing quizzes and exams, I will receive a certificate of completion, which can be submitted to the Yoga Alliance or a prospective employer as evidence that I have completed the 200-Hour Teacher Training program. Paying for the program and completing the hours alone does not mean I will pass the program.

I understand that I am required to attend 100% of the teacher training hours unless there is a family or medical emergency. If I miss any hours without providing a detailed written explanation of a family or medical emergency (including a doctor's note if it is a medical emergency), I will not graduate nor will I be refunded my tuition.

I understand that Sacred Sounds Yoga reserves the right to ask me to leave the program if my behavior is inappropriate, unethical or violates the Yoga Alliance ethical guidelines. Under such circumstances, I will not graduate nor will I be refunded my tuition.

I understand that Sacred Sounds Yoga reserves the right to ask me to leave the program should it appear that my health or physical practice is not at the level to fully participate in the training. Under such circumstances, I will not graduate, but I will be given a prorated refund, based on the amount of time I have attended in the training.

I understand that if I cancel more than 30 days prior to the start of training, I will receive a full refund, less my non-refundable \$500 deposit, which may be transferred toward a future training. If I cancel within 30 days before the start of training, I will receive a 50% refund, less my \$500 non-refundable deposit, which may be transferred toward a future training. **Once the program begins, tuition is non-refundable and non-transferrable.**
